I hereby state that I am the owner/person in charge of the patient and that I consent to the patient being examined, assessed, and treated with veterinary care including, but not limited to, Animal Biomechanical Medicine.

I understand that:

- Animal Biomechanical Medicine involves the identification of biomechanical dysfunction in the body and the application of a range of therapies to restore healthy function;
- Techniques applied to my animal may include soft tissue therapies and those derived from Chiropractic and Osteopathy;
- All animal handling carries inherent risks to the animal, handler, and practitioners;
- Wade Veterinary Services may refuse to handle my animal if the situation is deemed unsafe for any person, animal or third party or if important information such as x-rays and veterinary reports are not made available when requested;
- Referral to my usual vet or another practitioner may be advised;
- Rehabilitation strategies or changes in my animal's lifestyle may be required for successful outcomes; and
- While reasonable care is taken any form of treatment carries risk of adverse effect.

I agree:

- To follow veterinary instruction regarding safe handling and safe practices; and
- To pay in full for assessment, travel, and treatment on the day of service.

- Referral to an Animal Biomechanical Medicine vet, my usual vet or another practitioner may be advised;
- Rehabilitation strategies or changes in my animal's lifestyle may be required for successful outcomes; and
- While reasonable care is taken any form of treatment carries risk of adverse effect.

I agree:

- To follow practitioner's instruction regarding safe handling and safe practices; and
- To pay in full for assessment, travel, and treatment on the day of service.

<u>Consent – Underwater Treadmill Hydrotherapy for Dogs</u>

I hereby state that I am the owner/person in charge of the patient and that I consent to the patient being assessed by a qualified hydrotherapist or onsite veterinarian to determine if hydrotherapy is suitable for my patient.

Once suitability has been confirmed, I consent to my patient having ongoing hydrotherapy with a qualified hydrotherapist. This may be assisted or unassisted.

I understand that:

- Assessment involves the identification of any reasons not to undertake hydrotherapy;
- My hydrotherapist may request another assessment part-way through a rehabilitation regime if concerned about the welfare of the patient;
- All animal handling carries inherent risks to the animal, handler, and practitioners;
- Wade Veterinary Services may refuse to handle my animal if the situation is deemed unsafe for any person, animal or third party or if important information such as x-rays and veterinary reports are not made available when requested;
- Referral to my usual vet or another practitioner may be advised;
- Other rehabilitation strategies or changes in my animal's lifestyle may be required for successful outcomes; and
- While reasonable care is taken any form of rehabilitation carries inherent risk of adverse effect.

I agree:

- To follow the hydro-therapist's instruction regarding safe handling and safe practices;
- To pay in full for all assessment and/or hydrotherapy on the day of service;
- That Wade Veterinary Services can share & request patient information including history, radiographs, medication, and treatment with other practitioners where I have given written consent; and
- That I have read, and understood the terms outlined above.

I understand the estimated fee will be between \$80 and \$152.50 depending on my patient's needs as per the table provided in the following link:

(Zebris Canidgait Treadmill)

- Referral to my usual vet or another practitioner may be advised;
- Other rehabilitation strategies or changes in my animal's lifestyle may be required for successful outcomes; and
- While reasonable care is taken any form of rehabilitation carries inherent risk of adverse effect.
